Emeka Nwachukwu



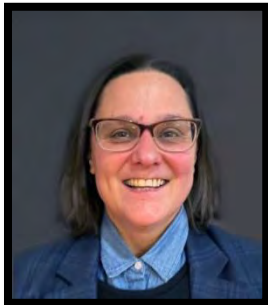
